Directions to the show hall will be sent with your confirmation. The show hall is handicap accessible and temperature controlled by large fans when needed.

There is no air conditioning in the arena area. No smoking is allowed indoors. Early departures must have permission from the Show Manager. Single cage size is approximately 22" x 22" x 22" and is included with your entry. The Club will not be liable for any damage or loss of exhibitor property. Security Cages, even half sized must purchase an extra ½ cage. There is no snack bar available. Food truck possibility to confirmed at a later date. Litter will be provided. **Clerks/Stewards:**

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household pet color class prefix will be scored for CFA Awards.

Late Fee: \$25.00 CAD/US on absentee entries unpaid 2 weeks after show. No extra fee for online entries. Payment is due within 10 days as per show rule 6.21. Entries sent in the final 10 days that pay at check-in must be paid in CASH. Make cheques payable to Golden Triangle Cat Fanciers. No Refunds or Cancellations after the entry clerk has confirmed your entry or failure to bench. No substitutions after the closing date. Check your confirmation for accuracy & contact the entry clerk with any corrections BEFORE THE CLOSING DATE. E-transfer will be available to Canadian exhibitors, details will be on your confirmation. **New Exhibitor Information:** <https://newexhibitor.cfa.org>. Please let the

entry clerk know you are new to showing. PASSPORTS are required for border crossings PLUS a rabies certificate for your cat. Kittens for Sale must have valid proof of age and be over 4 months old. **Health:** It is strongly recommended that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed Veterinarian against feline panleukopenia, feline rhinotracheitis, calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of each entry must be clipped prior to benching. Failure to do so will subject the entry to disqualification. Declawed cats are not eligible for competition. **HOUSEHOLD PETS** must be at least 4 months old, over 8 months old must be neutered or spayed but not declawed. **Cats/Kittens** are not permitted to be kept in carriers during the show.
